



## **SUPPRESSOR INSTRUCTIONS, INFORMATION, AND WARNINGS**

We here at Elevated Silence take a great deal of pride in the craftsmanship of our products. From the design, R&D, material selection, manufacturing, and care that goes into each and every suppressor. We believe in a fully involved way of thinking to make sure our customers can enjoy their products for a lifetime. **PLEASE READ THE BELOW INSTRUCTIONS AND INFORMATION BEFORE USING YOUR SUPPRESSOR. FAILURE TO FOLLOWING THE INSTRUCTIONS AND WARNINGS BELOW MAY RESULT IN DAMAGE TO THE SUPPRESSOR, HOST FIREARM, OR PERSONAL INJURY.**

**FOLLOW PRODUCT INSTRUCTIONS** – It is critical to follow the below instructions and the product specific instructions enclosed with your Elevated Silence suppressor to ensure proper and safe use. Suppressors are potentially dangerous. Elevated Silence cannot be and is not responsible for any damages resulting from improper use or failure to follow instructions. **GENERAL USE INSTRUCTIONS** – Follow the below rules when using your suppressor to avoid damage to the suppressor, host firearm, or personal injury.

- Ensure the host firearm is unloaded before attaching or removing the suppressor by removing the magazine and visually inspecting the chamber.
- Ensure the suppressor is firmly attached to the host firearm and threaded properly onto the barrel or muzzle brake. Be careful not to cross thread the suppressor and ensure it is fully seated with no additional treads showing. Hand tighten only.
- Ensure the suppressor is free from all obstructions such as mud, dirt, or water. **NEVER ATTEMPT TO SHOOT AN OBSTRUCTED SUPPRESSOR (including through water).**
- If the suppressor uses a muzzle brake, ensure the caliber of the muzzle brake is appropriately matched to the host firearm. Just because the brake threads on the barrel does not mean the bullet will freely pass through the break. **NEVER ATTEMPT TO SHOOT A BULLET THROUGH A BRAKE WITHOUT FIRST ENSURING THE BULLET DIAMETER IS PROPERLY MATCHED TO THE BREAK.**
- Ensure the suppressor is rated for the caliber and type of bullet you intend to shoot. **NEVER ATTEMPT TO SHOOT A BULLET THROUGH A SUPPRESSOR WITHOUT FIRST ENSURING THE SUPPRESSOR IS RATED FOR THE BULLET DIAMETER.**
- Do not place anything in the suppressor that may become lodged inside (such as barrel cleaning patches).
- Allow the suppressor to cool before touching after use unless wearing heat resistance gloves and do not allow the suppressor to come into contact with skin or combustible material while still hot.
- Clean the brakes and threads as needed with gun cleaning solvent.

**EVOLUTION™ SPECIFIC INSTRUCTIONS**- The Evolution™ suppressor is rated for calibers .17HMR through .300 Win Mag. The Evolution™ may be used during full automatic firing, subject to the below restrictions:

- **Ammo Restrictions** - Full automatic firing must be limited to no more than three 30 round magazines of .223/5.56 ammunition or two 30 round magazines of .308/7.62x39 ammunition, followed by a sufficient break to allow the suppressor to cool. Failure to follow these instructions may result in damage to the internal structure of the suppressor and reduce its effectiveness and lifespan.
- **Barrel Length Restrictions** – Full automatic firing should not be performed using barrels shorter than the following:
  - .300 Win Mag = 20 inches
  - .308/7.62x39 = 16 inches
  - .223/5.56 = 10.5 inches
  - 300 BLK = 8 inches

Failure to follow these instructions may result in an accumulation of unburnt powder in the suppressor which may ignite and explode causing damage to the suppressor, host firearm, or personal injury.
